

THE LOWE'S BUCKET OF GIFTS GIVEAWAY OFFICIAL RULES

NO PURCHASE NECESSARY TO PARTICIPATE, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. THESE RULES INCLUDE A BINDING ARBITRATION PROVISION AND CLASS ACTION WAIVER IN SECTION 8, WHICH LIMIT THE REMEDIES AVAILABLE TO YOU IN THE EVENT OF A DISPUTE. PLEASE READ THEM CAREFULLY. VOID WHERE PROHIBITED BY LAW.

The Lowe's Bucket of Gifts Giveaway ("Promotion") is sponsored by Lowe's Home Centers, LLC, 1000 Lowe's Blvd., Mooresville, NC 28117 ("Sponsor") and is administered by Genesco Sports Enterprises, Inc., 5944 Luther Lane, Suite 500, Dallas, TX 75225 ("Administrator").

1. ELIGIBILITY: The Promotion is open only to:

- 1) Individuals who are legal U.S. residents who, at the time of participation, reside in the fifty (50) United States or the District of Columbia, are at least eighteen (18) years of age and age of majority in their state of residence, and are enrolled in MyLowe's Rewards loyalty program (a "**Participant**"); and
- 2) Primary Admins who are legal U.S. residents who, at the time of participation, reside in the fifty (50) United States or the District of Columbia, are at least eighteen (18) years of age and age of majority in their state of residence on behalf of a PRO business (defined as a business that provides services in any of the following industries: construction, home improvement/repair, property management, and/or maintenance management sectors, or other sector as determined by Lowe's in Lowe's sole discretion) ("**PRO Business**"), that is registered and located in the fifty (50) United States or the District of Columbia and are enrolled in MyLowe's Pro Rewards loyalty program (also a "**Participant**"). **Organizations that are ineligible as a result of Organization's policies and/or applicable law are ineligible to participate in the Promotion.**

It is free to open a Lowes.com personal account to enroll in MyLowe's Rewards or a Lowes.com business account to enroll in MyLowe's Pro Rewards. Accounts are subject to Lowe's terms and conditions which can be found at [Lowes.com/terms](https://www.lowes.com/terms). Verification and compliance with eligibility shall be determined by Sponsor, in Sponsor's sole discretion.

Void where prohibited or restricted by law. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising, promotion or production agencies, and web masters/suppliers (collectively, "Promotion Entities") and each of the foregoing's immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each (whether or not related) are not eligible to participate or win. All federal, state and local laws apply. Participation constitutes Participant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions and interpretations, which are final and binding in all matters related to the Promotion.

2. PROMOTION TIMING AND OVERVIEW: The Promotion begins at the opening time of the Lowe's retail store (excludes outlets and Lowe's Pro Supply ("LPS") store locations; only regular Lowe's Retail stores are included) location ("Lowe's Location") on November 28, 2025 and ends at the closing time of the Lowe's Location on November 28, 2025 or when all fifty (50) First Prizes are distributed, whichever occurs first ("Promotion Period"). The time clock of the Lowe's Location is the Promotion's official clock.

3. HOW TO PARTICIPATE: During the Promotion Period, Participant must be one of the first fifty (50) Participants to visit a Lowe's Location and provide proof of eligibility, including proof of loyalty program membership by either showing associate a valid member ID on the Lowe's app or Lowe's mobile website or asking the associate to look up loyalty account with phone number. There is a limit of one (1) prize per Participant, regardless of Lowe's Location. First Prizes are subject to availability and are only available

while supplies last at the Lowe's Location. If your First Prize contains the Grand Prize certificate, then you are the potential Grand Prize winner (subject to verification of eligibility and compliance with these Official Rules and the prize-claim process, see Section 5 below). If your bucket does not contain the Grand Prize certificate, you are not the Grand Prize winner.

4. PRIZE, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

Grand Prize - One (1) per Lowe's Location (1,740 total): Certificate ("Prize Code") redeemable at a Lowe's Location in-store only on or before **November 30, 2025** for one (1) in-stock major appliance priced \$2,000.00 or less. Prize Code is not a credit or debit card, has no implied warranties. Prize Code is not redeemable for cash, not transferable and can't be replaced if lost or stolen. Void if altered, defaced, copied, transferred, or sold (through any on-line auction or otherwise). ARV of each Grand Prize is up to \$2,000.00.

First Prize - Fifty (50) per Lowe's Location (87,000 total): "Bucket of Gifts" consisting of one (1) Great Stuff Gap Canister, one (1) Valspar Paint Brush, one (1) WD40 Product, one (1) coupon for a Free Paint Sample, and one (1) additional product of Sponsor's choice. The WD40 product and additional product shall be determined by Sponsor, in Sponsor's sole discretion, and are subject to change or be swapped out based on availability. ARV of each First Prize is up to \$100.00. Buckets will also include additional coupons and offers that are subject to terms and conditions stated on the coupon or offer.

Total ARV for each Lowe's Location is up to \$7,000.00, and Total ARV for all Lowe's Locations is up to \$12,180,000.

The odds of winning depend on the number of Participants and the order in prizes are claimed at each Lowe's Location.

No more than fifty (50) First Prizes and one (1) Grand Prize are available per Lowe's Location. In no event will more prizes be awarded than are stated in these Official Rules. If for any reason, including but not limited to an administrative, printing, production, computer or other error or due to incorrect announcements of any kind, more than fifty (50) First Prizes and one (1) Grand Prize are distributed per Lowe's Location, or more prizes are claimed than are intended to be awarded according to these Official Rules, the intended number of prizes will be awarded in a random drawing from among all purportedly valid claims received for a given prize category. Prizes that are unclaimed or unredeemed will not be awarded.

Prizes are not transferable or redeemable for cash and a prize substitution will not be allowed, except at sole discretion of the Sponsor who reserves the right to substitute a prize of equal or greater value if an advertised prize becomes unavailable. Any unclaimed prizes will not be awarded. Each winner is solely responsible for paying all applicable federal, state, and local taxes, if any, and all other unspecified expenses associated with the acceptance and/or use of prize. Any portion of a prize not accepted or used by a winner for any reason will be forfeited. Any difference between stated value and actual value will not be awarded. The **"Released Parties"** (as defined below) make no representations or warranties and hereby disclaims any and all representations and warranties, express or implied, concerning the Prizes furnished to a Participant hereunder.

5. GRAND PRIZE WINNER VERIFICATION AND PRIZE CLAIM: The potential Grand Prize winner must have a valid email address. An invalid, non-working, or inactive email address may result in disqualification, as determined by Sponsor, in Sponsor's sole discretion. Potential Grand Prize winner must complete the following steps to claim Grand Prize:

- Potential Grand Prize winner must provide the Prize Code, email address associated with the Lowes.com account (Organization Primary Admin account for MyLowe's Pro Rewards loyalty account), and valid government-issued photo ID to the Lowe's Store Manager.
 - The name of the person claiming the Grand Prize must be the account holder of the Lowes.com account used to claim prize, otherwise, the prize claim may be deemed void. Multiple Participants may not share the same email address. In the event of a dispute over

the identity of a Participant, the prize claim will be declared as made by the authorized account holder of the email address used to claim the prize. Any person who tampers with or abuses any aspect of this

Promotion or otherwise attempt to undermine the legitimate operation of the Promotion by cheating, hacking, deception, or other unfair playing practices or intending to annoy, abuse, threaten or harass any other Participants or Sponsor representatives, as solely determined by the Sponsor, will be disqualified. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NORTH CAROLINA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN MECKLENBURG COUNTY, NORTH CAROLINA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
