

THE 2026 LOWE'S LEAGUES CUP SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE A PARTICIPANT'S CHANCES OF WINNING. THESE RULES INCLUDE A BINDING ARBITRATION PROVISION AND CLASS ACTION WAIVER IN SECTION 9, WHICH LIMIT THE REMEDIES AVAILABLE TO YOU IN THE EVENT OF A DISPUTE. PLEASE READ THEM CAREFULLY. VOID WHERE PROHIBITED BY LAW.

The 2026 Lowe's Leagues Cup Sweepstakes ("Promotion") is sponsored by Lowe's Home Centers, LLC, 1000 Lowe's Blvd., Mooresville, NC 28117 ("Sponsor") and is administered by Genesco Sports Enterprises, Inc., 5944 Luther Lane, Suite 500, Dallas, TX 75225 ("Administrator").

1. ELIGIBILITY: The Promotion is open only to:

- 1) Individuals who are legal U.S. residents who, at the time of entry, reside in the fifty (50) United States or the District of Columbia, are at least eighteen (18) years of age and age of majority in their state of residence, and are enrolled in MyLowe's Rewards loyalty program (a **"Participant"**); and
- 2) PRO businesses (defined as a business that provides services in any of the following industries: construction, home improvement/repair, property management, and/or maintenance management sectors, or other sector as determined by Lowe's in Lowe's sole discretion) (**"PRO Business"**), that is registered and located in the fifty (50) United States or the District of Columbia and are enrolled in MyLowe's Pro Rewards loyalty program (also a **"Participant"**). **Organizations that are ineligible as a result of their Organization's policies and/or applicable law are ineligible to participate in the Promotion.**

It is free to open a Lowes.com personal account to enroll in MyLowe's Rewards or a Lowes.com business account to enroll in MyLowe's Pro Rewards. Accounts are subject to Lowe's terms and conditions which can be found at [Lowes.com/terms](https://www.lowes.com/terms). Verification and compliance with eligibility shall be determined by Sponsor in its sole discretion.

Void where prohibited or restricted by law. Employees of Sponsor, Administrator, Major League Soccer, L.L.C. ("MLS"), Soccer United Marketing, LLC ("SUM"), Pro Soccer Development, LP ("MLSNP"), and Player Development, LLC ("PDEV" and together with MLS, SUM, and MLSNP, collectively, the "SUM Entities"), Electronic Arts Inc., and each of their respective parent companies, subsidiaries, affiliates, advertising, promotion or production agencies, and web masters/suppliers (collectively, "Promotion Entities") and each of the foregoing's immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each (whether or not related) are not eligible to enter or win. Participation constitutes Participant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions and interpretations, which are final and binding in all matters related to the Promotion.

2. PROMOTION PERIOD: The Promotion begins on July 27, 2026 at 12:00:01 a.m. Eastern Time ("ET") and ends on August 15, 2026 at 11:59:59 p.m. ET ("Promotion Period"). Sponsor's computer is the official time-keeping device for this Promotion.

3. HOW TO ENTER: During the Promotion Period, visit www.lowes.com/events/register/the-2026-lowes-leagues-cup-sweepstakes ("Website") and log into your MyLowe's Rewards or MyLowe's Pro Rewards account, verify your account submission information, and click the "Enter" button to receive one (1) entry into the Promotion (an "Online Entry"). For PRO Businesses, the individual entering the Promotion on behalf of the PRO Business must be the Primary Admin of the PRO Business Account who is a legal resident of the fifty (50) United States (including the District of Columbia) and at least eighteen (18) years

old and age of majority in their state of residence at the time of Entry. **Limit: One (1) Online Entry per account for the entire Promotion Period.**

BONUS ENTRIES: Up to twenty (20) bonus entries (one (1) per day) may be earned in two (2) ways as described below (each a "Bonus Entry"). Please note, you must enter the Promotion via the Website to establish your one (1) initial Online Entry to obtain a Bonus Entry(ies).

- 1) Earn one (1) Bonus Entry by making a Qualifying Purchase (as defined below) in store or online during the Promotion Period. Participant's purchase must be identified by logging into their Lowes.com personal or business account online or entering their phone number associated with their Lowes.com personal or business account at time of an in-store purchase.
 - **Qualifying Purchases for MyLowe's Rewards members (personal accounts):** "Qualifying Purchases" are MyLowe's Tracked Purchases that have been settled and fulfilled and appear on the Personal Account purchase history excluding: rental fees; permits, project fees; shipping and handling; delivery; surcharges; service fees; sales and use taxes; product fees, purchases of Lowe's Gift Cards or other third-party Gift Cards, or purchases made with loyalty rewards, including MyLowe's Money, or other promotional items (such as free items), or purchases made using payment tender currently saved to an existing PRO Account.
 - **Qualifying Purchases for PRO Businesses:** "Qualifying Purchases" are PRO Tracked Purchases calculated based on the actual amount paid on any completed purchases of products made by the Organization during the MLPR Program Period after any allowable discounts are applied, if any, and excluding: rental fees; warranty; Lowe's Protection Plans; shipping and handling; delivery; surcharges; service fees; sales and use taxes; and product fees. Qualifying Purchases do not include: (i) purchases of electrical cable and electrical wires; (ii) purchases of Lowe's Gift Cards or Gift Certificates or other third-party Gift Cards or Gift Certificates; (iii) purchases made using an employee discount (iv) purchases or transactions made with MLPR Rewards or other promotional items (such as MLPR MyLowe's Money and free items), whether made in store, online or through the Lowe's app; (v) government purchases; (vi) purchases made for personal use, including any purchase using a Personal Account or Military Discount; or (vii) purchases made on tender previously registered by another Organization.
- 2) **To earn one (1) Bonus Entry without making a purchase:** hand print your first and last name, business name (for PRO Businesses only), email address (associated to your Lowes.com personal or business account), and phone number (associated to your Lowes.com personal or business account) on a 3" x 5" index card or piece of paper and place your entry into an outer-mailing envelope with proper postage affixed and mail it to: The 2026 Lowe's Leagues Cup Sweepstakes, c/o GSE, PO Box 130, Dept. 26-8128-06, Glencoe, MN 55336-0130. Mail-in Bonus Entries must be postmarked by August 15, 2026 and received by August 21, 2026. Limit one (1) Mail-in Bonus Entry per outer mailing envelope. No responsibility is assumed by Sponsor for lost, late, illegible, incomplete, mutilated, stolen, postage-due or misdirected mail. Once submitted, all Bonus Entries and entry information become the exclusive property of Sponsor and will not be acknowledged, nor will they be returned. No facsimiles allowed.

Limit one (1) Bonus Entry per day, regardless of the method used to obtain a Bonus Entry. For Clarity: Limit one (1) Bonus Entry per day regardless of the number of Qualifying Purchases made in a single day.

The Online Entry and each Bonus Entry shall hereinafter be referred to as an “Entry”.

All Participants must have a valid email address. Entries specifying an invalid, non-working, or inactive email address will be disqualified and ineligible to win. You must complete all required information to be eligible to enter. Incomplete, illegible, corrupted, or untimely Entries are void and will be disqualified. The name of the person submitting the Entry into the Promotion must be the authorized account holder of the email address used to enter, otherwise, Entry may be deemed void. Multiple Participants may not share the same email address. In the event of a dispute over the identity of a Participant, Entry will be declared as made by the authorized account holder of the email address used during the entry process. The potential winners may be required to provide identification sufficient to show that they are the authorized account holder of such email account.

Each Entry must be manually keystroked and/or manually entered by the individual Participant. Automated and/or repetitive electronic submission of Entries (including but not limited to Entries made using any script, macro, bot or sweepstakes service) will be disqualified and transmissions from any such scripts, macros, bots or sweepstakes services or related email addresses or IP addresses may be blocked. If it is discovered that a Participant used multiple email addresses, phone numbers and/or mailing addresses, or manipulated such information for the purpose of obtaining more than the allowed number of Entries (as stated herein) into the Promotion, such person will be disqualified and any prize won, shall be forfeited.

4. RANDOM DRAWING: On or about August 24, 2026, the Administrator will randomly select the potential winners from among all eligible Entries received. The potential winners are not declared the official winners of a prize unless and until they have been verified and notified that verification is complete (see Section 6). Limit one (1) prize per household or PRO Business. For clarity, multiple individuals within a household who meet the eligibility criteria are eligible to enter; however, only one (1) prize is allowed per household.

5. PRIZES, APPROXIMATE RETAIL VALUES (“ARV”), AND ODDS OF WINNING:

Grand Prize (1): A trip for winner (if a PRO Business, must be the authorized representative of the winning PRO Business) and winner’s three (3) guests to attend the 2026 Leagues Cup final (the “Match”) scheduled to occur in September 2026 (date and location, and travel dates will be determined by Leagues Cup and/or Sponsor at a date later than the publishing of these rules). Trip consists of round-trip coach-class air transportation for winner and three (3) guests (from a major airport near the winner’s home); two (2) standard double-occupancy hotel rooms for two (2) nights; and four (4) Match tickets. If winner resides within a 250 mile-radius of the Match location, Sponsor reserves the right to substitute round-trip ground transportation to/from Winner’s residence in lieu of air transportation. Winner only will also receive one (1) Inter Miami CF home jersey signed by Messi, one (1) EA SPORTS™ FC 27 Game Code (PlayStation or Xbox gaming code, winner’s choice; gaming system not included), and one (1) \$500.00 Lowe’s E-Gift Card (subject to Lowe’s standard gift card terms at <https://www.lowes.com/giftcards>). Match tickets are subject to certain terms and conditions, which may include the requirement that winner must download a mobile ticketing app (valid email address required) and present tickets for entry via a mobile device. ARV of each Grand Prize is up to \$10,419.99, depending on winner’s point of departure and destination airport. See below for prize conditions.

First Prize (50): One (1) EA SPORTS™ FC 27 Game Code (PlayStation or Xbox gaming code, winner’s choice; gaming system not included) and one (1) \$20.00 Lowe’s E-Gift Card (subject to Lowe’s standard gift card terms at <https://www.lowes.com/giftcards>). ARV of each First Prize is \$89.99.

Total ARV of all prizes is up to \$14,919.49.

The odds of winning a prize depend on the total number of eligible Entries received during the Promotion Period.

Grand Prize - Prize Conditions: Ground transportation, parking, upgrades, meals, gratuities, souvenirs, luggage fees, and all other expenses not specified herein are solely the winner's responsibility. A minor child may accompany winner as a guest only if minor's parent or legal guardian is the winner or one (1) of winner's other guests. Any minor guest must be accompanied at all times during all prize-related events by minor's parent or legal guardian. Once guests are selected, they may not be substituted, except in Sponsor's sole and absolute discretion. Winner will be required to provide a credit card to hotel to keep on file prior to hotel check-in and is solely responsible for all incidental charges and may be required to sign an additional liability release for the use of the accommodations. Sponsor assumes no responsibility for canceled, delayed, suspended or rescheduled events (including, but not limited to airline flights and the Match) or any act or omissions whatsoever by the air carriers, hotels, venue operators, transportation companies, prize providers or any other persons providing any prize-related services or accommodations beyond its control. Airline tickets are non-refundable/non-transferable and are not valid for upgrades and/or frequent flyer miles. The Promotion Entities reserve the right to revoke the full or partial prize from any winner or a guest who the Promotion Entities deem, in any of their sole discretion, may be intoxicated, be a safety risk, has violated any venue or MLS policy or law, fails to comply with the MLS's (or its designee's) health and safety protocols, brings the Promotion Entities into disrepute, engages in behavior that is obnoxious or threatening, illegal, or that is intended to threaten or harass any other person, or that in any way disparages or adversely affects the reputation, image, and/or customer goodwill of Promotion Entities or any of the Promotion Entities' services, products, trademarks, service marks, or logos. In the event winner or guest engages in behavior during travel that (as determined by the Promotion Entities in their discretion) is illegal, tortious, or subjects winner or guest to arrest or detention, the Promotion Entities shall have no obligation to pay any damages, fees, fines, judgments or other costs or expenses of any kind whatsoever incurred by winner or guest as a result of such conduct. For the avoidance of doubt, unused tickets cannot be refunded, exchanged or applied towards tickets for any subsequent event or for cash. For all prizes: Prizes are not transferable or redeemable for cash and a prize substitution will not be allowed, except at sole discretion of the Sponsor who reserves the right to substitute a prize of equal or greater value if the advertised prize becomes unavailable. An unclaimed prize will not be awarded. Winner is solely responsible for paying all applicable federal, state, and local taxes, if any, and all other unspecified expenses associated with the acceptance and/or use of prize. The Grand Prize winner will be required to give their social security number, to Sponsor or Administrator as a condition of receiving a prize and will receive an IRS Form 1099 for the stated value of their prize, if applicable. Any portion of a prize not accepted or used by a winner for any reason will be forfeited. Any difference between stated value and actual value will not be awarded.

6. WINNER NOTIFICATION AND VERIFICATION: The potential winners are subject to verification of eligibility and compliance with these Official Rules.

If a potential winner is a Participant with a Lowe's Personal Account: The potential winners will be notified by the Administrator via email, within two (2) business days of the random drawing. The potential winners will be required to follow the instructions within the notification within seventy-two (72) hours (twenty-four (24) hours for the potential Grand Prize winner) or prize may be forfeited and awarded to an alternate winner. As part of the prize-claim process for the Grand Prize, the potential Grand Prize winner will be required to complete, sign and return an IRS Form W-9 (including their social security number or employer identification number) and an Affidavit of Eligibility/Liability Release with (where lawful) a publicity release within twenty-four (24) hours beginning at the time the documents are sent by Administrator or prize may be forfeited in its entirety and awarded to an alternate winner, in Sponsor's sole discretion. If a potential winner is a PRO Business: The Primary Admin of the PRO Business will be notified by the Administrator, via email, within two (2) business days of the random drawing. The Primary Admin is solely responsible for identifying the PRO Business authorized representative who may accept the prize. The authorized representative must be (a) a legal resident of the fifty (50) United States (including the District of Columbia); (b) at least eighteen (18) years old and age of majority in their state of residence at the time of entry; (c) an employee of the PRO Business; and (d) verified as able to accept the prize by their PRO Business owner. Additionally, the Primary Admin of the PRO Business is solely responsible for coordinating the PRO Business' authorized representative's Prize acceptance and fulfillment and must have authority to do so. divert any Promotion email, including any winner notification email, to a spam or junk folder. Additional prize details (for Grand Prize) will be provided to the winner at the time of notification. Lowe's E-Gift Card Prizes and EA SPORTS™ FC 27 Game Codes will be emailed within two (2) weeks of winner verification.

7. RELEASE OF LIABILITY: As a condition of participating, Participants agree (and agree to confirm in writing, if requested): (a) to release and hold harmless the SUM Entities, Sponsor, Promotion Entities, and each of their respective parent companies, affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers, and each of the foregoing entities' respective officers, directors, stockholders, employees, designees and agents ("**Released Parties**"), Instagram, and Meta from any liability for any injuries, losses or damages of any kind to person(s) including, without limitation, injury or death, or property, or any claims based on publicity rights, defamation or invasion of privacy, resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in this Promotion or any Promotion-related activities, including travel thereto; (b) under no circumstances will Participant be permitted to obtain awards for, and Participant hereby waives all rights to claim, punitive, incidental, consequential, or any other damages, other than for actual out-of-pocket expenses; (c) all causes of action arising out of or connected with this Promotion, or any prize awarded, shall be resolved individually, without resort to any form of class action; and (d) any and all claims, judgments, and award shall be limited to actual out-of-pocket costs incurred, excluding attorneys' fees and court costs. LIABILITY LIMITATIONS: Released Parties are not responsible for lost, late, misdirected, incomplete, or non-delivered Entries; or for interrupted or unavailable satellite, network, server, Internet Service Provider, Website, telephone or other connections, availability or accessibility, or miscommunications, or failed computer, satellite, telephone or cable transmissions, or lines, or technical failure or jumbled, corrupted, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures, or technical errors or difficulties, or other errors of any kind whether human, mechanical, electronic or network or the incorrect or inaccurate capture of an Entry or other information or the failure to capture, or loss of, any such information. Any person who tampers with or abuses any aspect of this Promotion or otherwise attempt to undermine the legitimate operation of the Promotion by cheating, hacking, deception, or other unfair playing practices or intending to annoy, abuse, threaten or harass any other Participants or Sponsor representatives, as solely determined by the Sponsor, will be disqualified. Released Parties are not responsible for injury or damage to Participant's or to any other person's computer related to or resulting from participating in this Promotion or downloading materials from or use of the promotional Website. Should any portion of the Promotion be, in Sponsor's sole opinion, compromised by virus, worms, bugs, non-authorized human intervention, technical failures or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of Entries, Sponsor reserves the right, at its sole discretion, to suspend, modify or terminate the Promotion, and select the potential winner(s) in a random drawing from all non-suspect, eligible Entries/claims received prior to action taken or as otherwise deemed fair and appropriate by Sponsor. Sponsor reserves the right to only award the stated number of prizes. If, for any reason, more bona fide winners are notified than prizes available, prizes will be awarded in a random drawing from among all such persons. Inclusion in such drawing shall be each Participant's sole and exclusive remedy under such circumstances. Released Parties are not responsible for any incorrect or inaccurate information, whether caused by Website users, human error, tampering, hacking, or by any equipment or programming associated with or utilized in the Promotion, and assume no responsibility for any error, interruption, deletion, defect, delay in operation, or transmission, communications line failure, theft or destruction of any equipment used for this Promotion. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES").
