

THE LOWE'S ALL-PRO PRIZES MARCH SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

ONLY AN ORGANIZATION ASSOCIATED WITH A LOWES.COM PRO ACCOUNT IS ELIGIBLE TO ENTER AND WIN A PRIZE.

The Lowe's All-Pro Prizes March Sweepstakes ("**Sweepstakes**") is sponsored by Lowe's Home Centers, LLC ("**Sponsor**"), 1000 Lowe's Blvd., Mooresville, NC 28117 and is administered by Prize Logic, LLC, ("**Administrator**"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on March 7, 2022 at 12:00 AM Eastern Time ("**ET**") and ends on March 31, 2022 at 11:59:59 PM ET ("**Sweepstakes Period**"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** This Sweepstakes is open only to PRO businesses (defined as someone who works for or provides services in any of the following industries: construction, home improvement/repair, property management, and/or maintenance management sectors, or other sector as determined by Lowe's in Lowe's sole discretion) ("**PRO**"), that is registered and located in the fifty (50) United States and District of Columbia with an affiliated Lowes.com registered Business account in good standing at the time of entry and through prize fulfillment (it is free to register for a Lowes.com PRO account). These Official Rules must be accepted by an authorized representative upon winner verification who is a legal resident of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old and age of majority in their state of residence at the time of entry). Accounts are subject to [Lowes.com Terms and Conditions](#). Verification and compliance with eligibility shall be determined by Lowe's in Lowe's sole discretion. Valid driver's license required to win a grand prize (described below). Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising, and promotion agencies (collectively, "**Sweepstakes Entities**") and each of the foregoing's immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. **Government, Group Purchasing Organization parent organizations, and other organizations that are ineligible as a result of their organization's policies and/or applicable law are ineligible to participate in Sweepstakes.** All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's Lowes.com e-mail address will be the e-mail address submitted at the time of Sweepstakes entry. Entrants will not be allowed to change their e-mail address after submission.

- 3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, eligible entrants who either have or sign up for a Lowes.com account will automatically receive one (1) entry into the Sweepstakes. Limit: One (1) entry per eligible business during the Sweepstakes Period for having or signing up for a Lowes.com Pro account.

If more than the stated number of entries are received from the same business, telephone number and/or e-mail address, the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may be disqualified and not be eligible to win a prize. Subsequent attempts made by the same business to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the entrant being disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void.

- 4. RANDOM DRAWING:** On or around April 12, 2022, the Administrator will randomly select three (3) potential grand prize winners and, ten (10) potential first prize winners from all eligible entries received. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

- A. Grand Prizes (3):** Each grand prize is a Ford Truck (each a "**Grand Prize**"). There will be three (3) Grand Prizes available in the Sweepstakes. The quantity, ARV, and make/model of the Ford Trucks available are as follows;

- i. One (1) winner will receive a 2023 Ford Truck Lightning Pro and \$18,400 (to go toward taxes). ARV: \$64,400; or
- ii. Two (2) winners will each receive a Ford Truck F-150 XLT 301 Hybrid-4WD Crew Cab and \$21,200 (to go toward taxes). ARV of each: \$74,200

Sponsor will determine which Grand Prize winner gets which Grand Prize truck. The exact vehicle winner will receive will be based on availability at time of awarding and final decision of exact truck will be determined by the Sponsor in its sole discretion. Each Grand Prize vehicle make and model specifications will be determined by Sponsor, at its sole discretion. Each winner will be solely responsible for any additional features, equipment, accessories, upgrades or options to the prize vehicle. Each winner must take delivery of the Grand Prize vehicle, at his or her own expense, within 45 days of notice of availability of the Grand Prize from Sponsor at a dealership selected by Sponsor based on proximity to winner's PRO account address, or the Grand Prize may, at Sponsor's sole discretion, be forfeited. No other delivery option will be available. Each winner is responsible for all taxes and expenses, including but not limited to: sales tax, luxury tax, destination charges, registration, title and license fees, insurance and all other costs incurred in claiming, registering or using the prize vehicle. **Each winner must present his or her valid driver's license and provide satisfactory proof of liability insurance prior to the delivery of a Grand Prize.** Each Grand Prize vehicle details and

availability are subject to change. No more than three (3) Grand Prizes will be available in the Sweepstakes.

Grand Prize vehicle may differ from what is depicted in Sweepstakes advertising and from what is listed above. THE SWEEPSTAKES ENTITIES SHALL HAVE NO LIABILITY FOR ANY PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR OTHER DAMAGES OR EXPENSES RESULTING FROM OR ARISING OUT OF THE PRIZE VEHICLE OR ANY OTHER ASPECT OF WINNER'S ACCEPTANCE OR USE OF A PRIZE VEHICLE

B. First Prizes (10): Each first prize is an iHeart Radio advertising package worth \$15,000 and \$6,000 (to go toward taxes) (each a **"First Prize"**). First Prize winner will be connected with iHeart Media to collaborate on script writing, recording of their very own radio advertisements, and development of company specific media plan. Quantity, type and duration of spots vary based on market and will be determined by the company specific media plan developed by winner and iHeart Media not exceeding \$15,000. iHeart Media advertising package is subject to iHeart Radio Terms and Conditions. No more than ten (10) First Prizes will be available in the Sweepstakes. The ARV of each First Prize is \$21,000.

C. Total ARV: The total ARV of all prizes is \$422,800.

D. Odds of Winning: The odds of winning a prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.

E. General Conditions: There is a limit of one (1) prize per person. In no event will more than three (3) Grand Prizes and ten (10) First Prizes be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received.

6. HOW TO CLAIM A PRIZE: The potential winners are subject to verification of eligibility and compliance with these Official Rules. After the random drawing, Administrator will notify the potential winners via e-mail at the e-mail address provided at the time of registration. **The Primary Admin for each winner's PRO account is solely responsible for coordinating prize acceptance and fulfillment.** An authorized representative of each potential winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner's right to claim the prize, and may result in the prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a prize, the respective prize may be forfeited. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Upon verification of eligibility, the Primary Admin of the PRO account for each Grand Prize and First Prize will be contacted to make arrangements for the prize. Any portion of a prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for the applicable prize won. Sponsor will issue an IRS Form 1099-MISC for each winner. All other costs and expenses not expressly set forth herein shall be solely each winner's responsibility. The prizes will only be awarded to a verified Winner.

Sponsor will attempt to notify each potential winner as set forth above, but neither Sponsor nor its parent or affiliates are responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of the prize or force majeure, at Sponsor's sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding the prize for any reason.

7. **LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective parent companies, affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each of the foregoing entities' respective officers, directors, stockholders, employees, representatives, designees and agents ("**Released Parties**") are not responsible for and shall have no liability whatsoever for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules; and (ix) any unanswered or undeliverable winner notifications. (g) lost, late, stolen, misdirected, damaged or destroyed prize (or any element thereof); or (h) the negligence or willful misconduct by entrant.

If, for any reason, the Sweepstakes is not capable of running as planned, Sponsor reserves the right, at its sole and absolute discretion, to cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of a winner in a manner it deems fair and reasonable, including the selection of a winner from among eligible entries received prior to such cancellation, termination, modification or suspension. In no event will more prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner.

DISPUTES:** THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NORTH CAROLINA, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN THE COUNTY OF MECKLENBURG, NORTH CAROLINA. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NORTH CAROLINA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN MECKLENBURG COUNTY, NORTH CAROLINA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR RELEASED PARTIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE SWEEPSTAKES PERIOD, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.

Any attempted form of participation in this Sweepstakes other than as in these Official Rules is void. If it is discovered that a person has registered or attempted to register more than once using multiple phone numbers, e-mail addresses, residential addresses, multiple identities, IP addresses, use of proxy servers, or like methods, all of that person's entries will be declared null and void and that person will not be awarded any prize that he/she might have been entitled to receive.
