LOWE'S FOR PROS LOYALTY PROGRAM TERMS

These Terms apply to your access to, and participation in, the Lowe's For Pros Loyalty Program ("LFP Loyalty Program" or "Program"), which is operated by Lowe's Home Centers, LLC ("Lowe's). By participating in LFP Loyalty Program, you ("you") consent to these LFP Loyalty Program terms ("Loyalty Terms"). You acknowledge and agree that you have read and accepted these Loyalty Terms and are responsible for remaining knowledgeable about the Loyalty Terms.

By participating in the LFP Loyalty Program, you agree to be bound by these Loyalty Terms and all terms incorporated by reference. Your participation in the LFP Loyalty Program is subject to the Terms and Conditions of Use on www.lowesforpros.com, these Loyalty Terms and Lowe's US Privacy Statement (https://www.lowes.com/l/privacy-and-security-statement.html).

These Loyalty Terms do not alter the terms and conditions of any other agreement you may have with Lowe's for other products and services.

Lowe's, in its sole and absolute discretion, reserves the right to terminate, modify, add, end, or delete any of these Loyalty Terms, this Program or any sub-programs, benefits, special offers, or rewards, in whole or in part, at any time, including during the Program, with or without notice. Any changes or modifications will be effective immediately upon posting the revisions to https://www.lowesforpros.com/l/terms-and-conditions-of-use.html, and you waive any right you may have to receive specific notice of such changes or modifications.

Joining Lowe's For Pros Loyalty Program

A. LFP Loyalty Program Eligibility. Membership in the LFP Loyalty Program is available only to commercial customers in the United States. Personal use is prohibited. Commercial customers with a National Account contract, that participate in a cooperative purchasing program, or that receive other managed account discounts or rebates with Lowe's may not eligible for certain benefits of the LFP Loyalty Program. Resellers, as determined by Lowe's in its sole and absolute discretion, are not eligible for LFP Loyalty Program membership.

- **B. Registration.** In order to become a member of the LFP Loyalty Program ("**Member**"), registration is required and available through LowesForPros.com. You must also add at least one Registered Tender (as defined below) and enroll in the LFP Loyalty Program. LFP Loyalty Program accounts must be registered under a business name (the "**Organization**"). There may be a delay between initial registration and the time Program offers are available.
- **C. Accounts.** An individual may register a single account for an Organization and invite others to register individual accounts as part of the Organization. Please note benefits and rewards will

accrue and be distributed only to the "account holder" as defined in your LowesForPros.com account ("Account Holder"). The first individual LowesforPros.com account within an organization to register a LAR Authorized Buyer or LAR Plastic Card under a given Primary or Secondary LAR account into the Loyalty Program will receive Loyalty Benefits on behalf of the organization for that Primary or Secondary LAR Account. Subsequent LoweForPros.com accounts who attempt to register a LAR tender will not be able to do so and individual LAR Authorized Buyers or LAR Plastic Cards or underneath LAR Primary or Secondary Accounts are not recognized at this time. At this time, Lowe's Advantage Card (LAC) Accounts are not eligible to become Registered Tender in the Loyalty Program. - **E. LFP Tracked Purchases.** Once registered, Lowe's may track all the purchases that you make with Registered Tender ("**LFP Tracked Purchases**"). Lowe's will track purchases for the LFP Loyalty Program based only on purchases made with Registered Tender. Purchases may not appear in your account for up to 24 hours. This information may be shared with Lowe's service providers, subject to Lowe's Privacy Statement. Lowe's reserves the right to correct any errors. If you have any issues, please contact Lowe's at 844-LOW4PRO..
- **F. Special Offers**. Lowe's may, in its sole and absolute discretion, extend special offers to LFP Loyalty Program Members. Terms and conditions will be outlined in the offer details and are subject to change, including during the term of the offer. You may qualify for personalized discounts, benefits, and other rewards based on program engagement or membership type. You agree that Lowe's has the right to communicate these offers or rewards to you through mail, email, SMS, other computer electronic messaging or other means.

- **G.** Communications from LFP Loyalty Program. By registering your LowesForPros.com account, you agree and opt in to receive general and targeted advertising, marketing materials and other communications, including mail, email, SMS, other computer electronic messaging or other means, from Lowe's, LowesForPros.com or the LFP Loyalty Program.
- **H. Privacy.** When you register for, and/or participate in, the LFP Loyalty Program, you consent to Lowe's collection, use, and disclosure of your personal information, such as your name, address, valid email address and phone number and transaction history, pursuant to the <u>Lowe's Privacy Statement</u>. By voluntarily enrolling in the LFP Loyalty Program, you consent to the financial incentives outlined under these Loyalty Terms, including, but not limited to, "LFP Tracked Purchases" and "Special Offers", and the financial incentives outlined in any sub-program.
- **I. Deactivation of Your Account.** Lowe's reserves the right in its sole and absolute discretion to remove or delete any or all material from your LFP Loyalty Program or LowesForPros.com account at any time. Lowe's may also deactivate your LFP Loyalty Program or LowesForPros.com account for any reason and in its sole discretion. You acknowledge and agree that, except to the extent required by law, Lowe's has no obligation to make a copy, electronic or otherwise of LFP Tracked Purchases available to you at any time, including, without limitation, upon deactivation of your LFP Loyalty Program or LowesForPros.com account for any reason.
- **J. Termination of Service/Account.** Lowe's reserves the right in its sole and absolute discretion to suspend or terminate your access to and use of the LFP Loyalty Program, your LFP Loyalty Program or LowesForPros.com account, or any portion thereof, without liability, at any time and for any reason, with or without cause, and with or without notice to you. You may choose to deactivate your membership at any time by contacting Lowe's at [844-LOW4PRO.

Upon deactivation of your LFP Loyalty Program or LowesForPros.com account or termination of the LFP Loyalty Program, or upon your violation of these Loyalty Terms, your right to receive any benefits or otherwise participate in the LFP Loyalty Program will immediately cease to the extent permitted by laws and regulations. Notwithstanding the foregoing, unless Lowe's terminates your LFP Loyalty Program or LowesForPros.com account for cause, you will receive any reward earned up to the date of deactivation or termination, unless the reward terms specifically provide otherwise. "For cause" includes, without limitation, your fraud, abuse, or violation of these Loyalty Terms, in Lowe's sole and absolute discretion.

Upon suspension of your LFP Loyalty Program or LowesForPros.com account, you will not receive or accrue any benefits, and any purchases made during a suspension will not accrue as Qualifying Purchases, as defined below, for any sub-program.

Accrued spending does not constitute your property or the property of any Member. Any use of the terms "accrue" or "earn" in any materials relating to LFP Loyalty Program shall not infer that reward eligibility has any value. Accounts and Rewards earned cannot be purchased, sold, or transferred. Attempts to purchase, sell or transfer LFP Loyalty Program or LowesForPros.com accounts or Rewards in violation of these Loyalty Terms may result in Lowe's suspending, deactivating or terminating such account and voiding the Rewards, in Lowes's sole and absolute discretion.

K. Governing Law and Dispute Resolution.

Choice of Law, Jurisdiction and Venue:

You agree that this agreement and your participation in LFP Loyalty Program and any sub-program of the LFP Loyalty Program will be governed by the laws of the state of North Carolina. By participating in the LFP Loyalty Program or any sub-program of the LFP Loyalty Program, you consent to the exclusive jurisdiction and venue of the courts, tribunals, agencies and other dispute resolution organizations in Charlotte, North Carolina, in all disputes (i) arising out of, relating to or concerning the LFP Loyalty Program or any sub-program of the LFP Loyalty Program, these Loyalty Terms, any sub-program terms, and your participation therein; (ii) in which the Loyalty Terms or any sub-program terms is an issue or a material fact; or (iii) in which the Loyalty Terms or any sub-program terms is referenced in a paper filed in a court, tribunal, agency or other dispute resolution organization.

Waiver of Rights:

You agree to waive, to the fullest extent allowed by applicable law, any claims for punitive or exemplary damages and any right to pursue claims on a class or consolidated basis or in a representative capacity, which relate in any way to the LFP Loyalty Program or any sub-program of the LFP Loyalty Program or the Loyalty Terms or any sub-program terms.

Arbitration: Please read this section carefully because it affects rights that you might otherwise have. It provides for resolution of most disputes through arbitration instead of court proceedings.

Arbitration is different than court. There is no judge or jury, but the arbitrator can award damages. Arbitration is final, binding and subject to only limited review by a court. By participating in the LFP Loyalty Program or any sub-program of the LFP Loyalty Program, you agree to give up your right to a trial in court except for certain small claims as described below.

You agree that this arbitration section shall survive termination of this agreement. This section shall be broadly interpreted to encompass all disputes or claims arising out of or relating to your participation in the LFP Loyalty Program or any sub-program of the LFP Loyalty Program. Any dispute or claim made by you against Lowe's or against any of Lowe's subsidiary, parent or affiliated companies arising out of or related to your participation in the LFP Loyalty Program or any sub-program of the LFP Loyalty Program, whether based on contract, statute, tort, fraud, misrepresentation or any other legal theory, will be resolved by binding arbitration, except that you may take claims to small claims court if they qualify for hearing by such court.

You must first present any claim or dispute to Lowe's by contacting the Customer Care Center at 844-569-4776 to allow Lowe's the opportunity to resolve any dispute. You may request arbitration if your dispute cannot be resolved within sixty (60) days. The arbitration of any dispute or claim shall be conducted with the rules of a Nationwide Arbitration Organization as modified by this agreement. You and Lowe's agree that this agreement evidences a transaction in interstate commerce and this arbitration provision will be interpreted and enforced in accordance with the U.S. Federal Arbitration Act and federal arbitration law. Any such arbitration shall be brought and held in Charlotte, North Carolina, and will be conducted in the English language. An arbitrator may not (i) award relief in excess of or contrary to what this agreement provides; (ii) order consolidation or arbitration on a class wide or representative basis; or (iii) award punitive damages or any other damages aside from the prevailing party's actual damages, except that the arbitrator may award on an individual basis damages required by statute and may order injunctive or declaratory relief pursuant to an applicable consumer protection statute. In any arbitration applying those rules applicable to large and/or complex cases, the arbitrators may also apply the Federal Rules of Evidence, and the losing party may have the award reviewed in accordance with the review procedures set forth in the selected arbitrator's rules.

Any arbitration shall be confidential, and neither you nor Lowe's may disclose the existence, content or results of any arbitration, except as may be required by law or for purposes of enforcement or appeal of the arbitration award. The decisions of the arbitrators shall be binding and conclusive upon all parties involved, and any judgment or decision on any arbitration may be entered in and specifically enforced in any court having proper jurisdiction.

If any portion of this section is determined by a court to be inapplicable or invalid, then the remainder shall be given full force and effect.

Unless an applicable statute expressly permits awarding attorney's fees to the prevailing party, all administrative fees and expenses of arbitration will be divided equally between you and Lowe's.

Each party will bear the expense of its own counsel, experts, witnesses and preparation and presentation of evidence at any arbitration hearing.

L. Additional Terms.

- LFP Loyalty Program is not available and is void where prohibited by federal, state or local law.
- Fraud or abuse of any kind as determined by Lowe's in its sole and absolute discretion may result in termination of your membership in the LFP Loyalty Program and/or any subprogram thereof, in Lowe's sole and absolute discretion.
- Unless expressly provided therein, the LFP Loyalty Program or any sub-program offers cannot be combined with any (i) other promotion, discount, markdown, coupon, rebate or offer including any Lowe's volume or special discount programs (such as but not limited to, Contractor Pack, Buy in Bulk, Quote Support Program ("QSP"), Military Discount, Employee Discount, Lowe's price match guarantee, Special Value, New Lower Price, Was:Now, & credit discount offers); or (ii) associate discretion price adjustments.
- By registering and making purchases at Lowe's through your Registered Tender, you
 accept all terms and conditions in these Loyalty Terms and release Lowe's, its parent,
 subsidiaries and affiliates, and hold Lowe's, its parent, subsidiaries and affiliates, harmless
 from any claim, liability or damage relating to the LFP Loyalty Program or any subprogram, thereof.
- LOWE'S, ITS PARENT, SUBSIDIARIES OR AFFILIATES, MAKE NO EXPRESS OR IMPLIED REPRESENTATION OF WARRANTY AS TO ANY BENEFITS AND WILL NOT BE LIABILE FOR INJURY, DAMAGE, LOSS OR EXPENSE RESULTING FROM THE USE OR ACCEPTANCE OF ANY PART OF THE LFP LOYALTY PROGRAM OR ANY SUB-PROGRAM, THEREOF.

By participating in Paint Rewards, you agree to be bound by these Paint Rewards Terms and all terms incorporated by reference. Your participation in Paint Rewards is subject to the Terms of Use on www.lowes.com/l/privacy-and-security-statement.html).

Lowe's, in its sole and absolute discretion, reserves the right to terminate, modify, add, end, or delete any of these Paint Rewards Terms, Paint Rewards, benefits, special offers, or rewards, in whole or in part, at any time, including during Paint Rewards or the LFP Loyalty Program, with or without notice. Any changes or modifications will be effective immediately upon posting the revisions to https://www.lowesforpros.com/l/terms-and-conditions-of-use.html, and you waive any right you may have to receive specific notice of such changes or modifications.

Paint Rewards is a test offering, available only in select stores in select test markets, and only through December 31, 2020 ("Paint Rewards Promotion Period"), subject to Lowe's rights to terminate, modify, add, end or delete Paint Rewards at any time. For purposes of this Paint Rewards test program, the select stores are ("Participating Stores"):

LFP Loyalty Program Members and Paint Rewards members may be eligible for a reward ("**Reward**") based on their eligibility and Qualifying Purchases as defined below.

A. Paint Rewards Eligibility. In order to be eligible for the Paint Rewards program, you must: (1) be a LFP Loyalty Program Member; (2) have Registered Tender on file and active as detailed in the Registered Tender section of the Loyalty Terms; and, (3) have associated an Organization address with your LowesForPros.com account that has a zip code that is (i) in the same market (as determined in Lowe's sole and absolute discretion) as one of the Participating Stores listed below, or (ii) within a 10 mile radius of a NC Participating Store or SC Participating Store numbers: 416, 1776, 2442, 2920, 3040.

Qualifying Purchases. Qualifying purchases include net completed purchases of only paint applicators; brushes; rollers; kits; mini rollers; roller cages; trays/strainers; edgers/pads; poles;

faux applicators; handheld sprayers; stationary sprayers; stationary sprayer tips, hoses and access; handheld sprayer tips, hoses and access; power rollers; power roller access; paint sprayers; interior paint; exterior paint; exterior stains; floor coatings; primers; resurfacers; barn and fence paint; masonry waterproofers; and marine coatings (collectively "Paint and/or Paint Applicators") as further detailed below and subject to the exclusions below ("Qualifying Purchases").

Qualifying Purchases are calculated based on the actual amount paid on any completed purchases of Paint and/or Paint Applicators made by the Member during the Paint Rewards Promotion Period following enrollment using a Registered Tender at any Lowe's US store, Lowes.com and LowesForPros.com after any allowable discounts are applied, if any, excluding shipping and handling, delivery, and services fees and taxes. Qualifying Purchases do not include mistints, Paint and/or Paint Applicators purchases made using an e-procurement or punch-out solution, or Paint and/or Paint Applicators purchases made for personal use even if a Registered Tender is used. Completed purchases means the transaction has been settled and fulfilled.

Qualifying Purchases made with Registered Tender between the date of confirmed registration in Paint Rewards and December 31, 2020, will count towards the Rewards calculation as defined below. If an item from a Qualifying Purchase is returned, the return amount will be deducted from Qualifying Purchase spend toward earning Rewards. If the item is returned after a Rewards has been issued, your account may reflect a negative balance.

Other than Qualifying Purchases made in the month of registration, Lowe's will not recognize any purchases made before the month of registration as Qualifying Purchases and those purchases will not be eligible to be included in the Paint Rewards Calculation as set forth below.

Except for Lowe's Everyday 5% Credit discount offer, this offer cannot be combined with any (i) other promotion, discount, markdown, coupon, rebate or offer including any Lowe's volume or special discount programs (such as but not limited to, Contractor Pack, Buy in Bulk, Quote Support Program ("QSP"), Military Discount, Employee Discount, Lowe's price match guarantee, Special Value, New Lower Price, Was:Now, and additional credit discount offers or promotions); or (ii) associate discretion price adjustments.

B. Paint Rewards. Rewards will be issued in the form of a Visa® Prepaid Card ("**Loyalty Reward Card**"), subject to the terms and conditions of the card issuer. Each Loyalty Reward Card will expire 6 months from issuance.

Loyalty Reward Cards are issued by MetaBank®, Member FDIC, pursuant to a license from Visa U.S.A. Inc. Loyalty Reward Cards do not have cash access and can be used anywhere Visa® debit cards are accepted. Card valid through expiration date which is shown on the front of card. Cardholders are subject to the terms and conditions of the card as set forth by the issuing bank.

C. Paint Rewards Calculation. Rewards will be calculated at the end of each calendar month of the Paint Rewards Promotion Period based on the Qualifying Purchases made with Registered Tender during that month. Only purchases made with Registered Tender will count towards

Rewards calculation or tiers (i.e. purchases made with cash, gift card, checks, or tender not on file as Registered Tender will not count). Any Qualifying Purchases made on new Registered Tender will count towards the Reward earned in the month the Registered Tender was registered.

The Reward amount will be determined in accordance with the graduated percentage discounts in Table 1.1 below. Each tier and the reward amount earned is progressive, meaning the applicable percentage will only apply to the amount spent within the tier. It is possible for two tiers to be applied to one Reward.

Illustration: Customer registers for the LFP Loyalty Program on February 3, 2020 and adds a Registered Tender on February 5, 2020. Customer had two Qualifying Purchases using the Registered Tender in February 2020: \$500 on February 1, 2020, and \$1000 on February 6, 2020. From March 1 to December 31, 2020, customer spent an additional \$4000 in Qualifying Purchases in April 2020 and an additional \$5000 in Qualifying Purchases in October 2020 in separate transactions. The monthly Reward amount will be calculated as follows:

Lowe's will mail Loyalty Reward Cards after the month's end to the Account Holder who registered the tender at the address on file for the Organization as designated in the LowesForPros.com account. Please allow 6-8 weeks for processing.

D. Taxes. You are solely liable and responsible for any applicable federal, state, or local taxes arising out of your participation in the LFP Loyalty Program or the Paint Rewards program. Please consult your tax advisor concerning any tax consequences that may arise from your participation.

E. Additional Terms. In Lowe's sole and absolute discretion, Lowe's reserves the right to terminate any account that does not meet spend tiers during the Paint Rewards Promotion Period. In Lowe's sole and absolute discretion, in the event the Paint Rewards Program is extended beyond the initial Paint Rewards Promotion Period, Lowe's reserves the right to carry any negative balances through to the beginning of the next promotional period, and all tiers may reset to zero.
